Weighing 24.5kg and beginning from box 1, Dyna Gabba completed the 390m trial distance in a time of 22.09. Dyna Gabba placed 4th in a field of four starters beaten by 24.75 lengths. Dyna Gabba has been not cleared to race due to the greyhound sustaining a injury in the trial.</p> <p>Dyna Gabba underwent a post-trial veterinary examination and was found to have a grade three tear to the right triangle muscle. A 28 day stand down period was imposed. Connections advised Stewards that they will be retiring the greyhound.</p> <p>Off The Bit – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a right achilles tendon injury. Weighing 35.2kg and beginning from box 8, Off The Bit completed the 390m trial distance in a time of 22.09. Off The Bit was placed 1st in a field of four starters winning by 8.5 lengths. Off The Bit has been cleared to race.</p>
