SATISFACTORY TRIAL RESULTS:

TRAIL 1: The following Greyhounds performed a Stewards Satisfactory Trial – The trial took place over 311m with four greyhounds required to trial. The winning time of trial was 18.20:

Zipping Storm finished 1st, Disco Lemonade finished 2nd, Janiya Bale finished 3rd, Jugungal Black finished 4th.

Zipping Storm – Was stood down from racing at Warragul for Failing To Chase and connections wish to apply blinkers to the greyhound. Weighing 25.3kgs and beginning from box 1 winning by Neck. Zipping Storm has been cleared to race at all tracks except Warragul.

Jugungal Black – Was stood down from racing at Bulli for an unsatisfactory performance and has also not competed in an event for in excess of six months. Weighing 34.2kgs and beginning from box 3 beaten by ½ length. Jugungal Black has been cleared to race at all tracks except Bulli.

Janiya Bale – Was stood down from racing at Horsham for marring and connections wish to apply blinkers to the greyhound. Weighing 30.1kgs and beginning from box 6 beaten by 1 ¾ lengths. Janiya Bale has been cleared to race at all tracks except Horsham.

Disco Lemonade – Was stood down from racing at Horsham for an unsatisfactory performance. Weighing 28.7kgs and beginning from box 8 beaten by Neck. Disco Lemonade has been cleared to race at all tracks except Horsham.

TRIAL 2: The following Greyhounds performed a Stewards Satisfactory Trial – The trial took place over 311m with four greyhounds required to trial. The winning time of trial was 18.26

Naughty Cazza finished 1st, Shy Diva finished 2nd, Angus finished 3rd, George Knockin' finished 4th

George Knockin' – Was stood down from racing at Cranbourne for Failing to Chase. Weighing 28.8kgs and beginning from box 1 beaten by 1 % lengths. George Knockin' has been cleared to race at all tracks.

Naughty Cazza – Performed a satisfactory trial as the greyhound has not competed in an event for in excess of six months due to whelping. Weighing 26.6kgs and beginning from box 4 winning by 11 ¾ lengths. Naughty Cazza has been cleared to race at all tracks.

Shy Diva –Performed a satisfactory trail as the greyhound has not competed in an event for in excess of six months due to whelping. Weighing 27.5kgs and beginning from box 7 beaten by 11 /34 lengths. Shy Diva has been cleared to race at all tracks.

Angus - Performed a Stewards Satisfactory trial as connections wish to apply blinkers to the greyhound. Weighing 33.4kgs and beginning from box 8 beaten by $5\,\%$ lengths. Angus has been cleared to race at all tracks.
