Ms. Deglaitis pleaded guilty to the charge, Three Toots was found guilty and suspended the greyhound for 3 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(b), before any future nomination will be accepted.</p> <p>Meeting Comments:-</p> <p>Satisfactory Trial Results (Blinkers Off) - Beer On Tap trialled over the 425mt from box 1, weight 28.2kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 24.55, the greyhound was beaten by a margin of 7L.
