Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr P. Scofield, the trainer of Zero Five regarding the length of time since the greyhound last raced. Zero Five last raced on 19 December 2017 and is returning from tonsillitis. Pursuant to GAR 77A, Zero Five trialled over the 400mtrs from box 6, weight 32.8kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 23:16, the greyhound won by a margin of 1/2 length. Zero Five was Cleared.
