Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr K Chivell, the trainer of Little Miss Emm regarding the length of time since the greyhound last raced. Pursuant to GAR 77A, Little Miss Emm trialled over the 390m from box three, weight 25.3kg, the greyhound was placed fourth in a field of four.
