The time of the trial was 22.53, the greyhound was beaten by a margin of 3.75L. Lilly Shan was cleared.</p> <p>Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Fleur Terry, the trainer of Chucka Khan, regarding the length of time since the greyhound last raced.
