Acting under GAR 69(1) stewards charged Pancake with marring. Mr Clark pleaded guilty to the charge, Pancake was found guilty and suspended the greyhound for 12 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(c), before any future nomination will be accepted.

A post-race sample was taken from Yuko - winner of the event.

Mr Crawford pleaded guilty to the charge, Chinookan Blue was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
