Mr Conway pleaded not guiltyto the charge, Darcon Flash was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
