Meeting Comments:

Oriental Tiger – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at the Mount Gambier for failing to pursue the lure. Weighing 25.8kgs and beginning from box 1, Oriental Tiger completed the 390m trial distance in a time of 23.15. Oriental Tiger placed first in a field of four starters winning by a neck. Oriental Tiger has been cleared to race at all tracks except Mount Gambier.

Ace Marlow – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a right stopper injury. Weighing 31.1kgs and beginning from box 3, Ace Marlow completed the 390m trial distance in a time of 23.38. Ace Marlow placed third in a field of four starters by 3.5 lengths. Ace Marlow has been cleared to race.

Mystery Jet – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at the The Meadows for failing to pursue the lure by reason of injury. Weighing 32.5kgs and beginning from box 8, Mystery Jet completed the 390m trial distance in a time of 23.53. Mystery Jet placed fourth in a field of four starters beaten by 5.5 lengths. Mystery Jet has been cleared to race at all tracks/cleared to race at all tracks except The Meadows.
