Meeting Comments:

Compsognathus - Presented for a re-vet at the conclusion of kennelling as the greyhound was found to be injured at the Shepparton meeting on 28th January 2019. Compsognathus was examined by the oncourse veterinarian and found to be free from injury. Compsognathus was cleared to race.

Master Reid – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a change of kennel. Weighing 33.4kg and beginning from box 1, Master Reid completed the 390m trial distance in a time of 22.32. Master Reid placed 4th in a field of four starters beaten by 10 lengths. Master Reid has been cleared to race.
