Acting under the provisions of GAR 69(A)(1) Red Beryl was charged with failing to pursue the lure with due commitment throughout the event. Mrs. Johnston pleaded guilty to the charge, Red Beryl is suspended for 28 days at Sale and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.</p> <p>A sample was taken from Braemar Furey - the winner of the event.</p> <p>Supplementary Report: On Thursday 28 March 2019, GRV Stewards re-opened/reviewed the incident with Red Beryl. No video evidence of the Red Beryl racing incident was available. Upon review, the Stewards withdrew the charge and offence under GAR 69A and re-issued a fresh charge under GAR 71 for an unsatisfactory performance. Mrs Johnson, the trainer of Red Beryl, accepted the fresh charge and offence and as such, Red Beryl must now complete a Satisfactory Trial in accordance with GAR 71, before any further nominations will be accepted.</p>
