Satisfactory Trails:

Double Cross – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Virginia for fail to pursue. Weighing 34.0kgs and beginning from box 1, Double Cross completed the 390m trial distance in a time of 23.22. Double Cross placed 3rd in a field of 4 beaten by 9.25L. Double Cross has been cleared to race at all tracks except Virginia.

Wybie Blue — Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to change of kennel. Weighing 30.7kgs and beginning from box 5, Wybie Blue completed the 390m trial distance in a time of 22.58. Wybie Blue placed 1st in a field of 4 winning by 3L. Wybie Blue has been cleared to race.

Very Venom – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to left back muscle injury. Weighing 33.5kgs and beginning from box 8, Very Venom completed the 390m trial distance in a time of 22.79. Very Venom placed 2nd in a field of 4 beaten/by 3L. Very Venom has been cleared to race.

Dyna Arrow – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at the Warragul for fail to chase. Weighing 30.8kgs and beginning from box 1, Dyna Arrow completed the 390m trial distance in a time of 26.67. Dyna Arrow placed 4th in a field of 4 beaten by 54L. Dyna Arrow was not cleared. Dyna Arrow underwent a post-trial veterinary examination and found to have a fractured hock. A 90 day stand period was imposed.

Cedar Opal – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to an extended spell. Weighing 34.2kgs and beginning from box 6, Cedar Opal completed the 390m trial distance in a time of 23.25 Cedar Opal placed 3rd in a field of 4 beaten by 5L. Cedar Opal has been cleared to race.
