Satisfactory Trial Results:

Sofie Gogolac – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Bendigo for failing to chase. Weighing 28.1kgs and beginning from box 1, Sofie Gogolac completed the

390m trial distance in a time of 22.87. Sofie Gogolac placed 2nd in a field of 5 beaten by 11.25L. Sofie Gogolac has been cleared to race at all tracks except Bendigo.

Simmo Gogolac – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at The Gardens for failing to chase. Simmo Gogolac hasalso not started for nine months due to a change of kennel. Weighing 32.0kgs and beginning from box 3, Simmo Gogolac completed the 390m trial distance in a time of 23.16. Simmo Gogolac placed 4th in a field of 5 beaten by 15.5L Simmo Gogolac has been cleared to race at all tracks except The Gardens.

Madame Butterfly – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a left back muscle injury. Weighing 28.7kgs and beginning from box 5, Madame Butterfly was galloped on approaching the first turn and tailed off. Underwent a post-trial examination and was found to have sustained a right back muscle injury. A 28 day standdown period was imposed.

Super Panda – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Healsville for failing to chase. Weighing 31.0kgs and beginning from box 7, Super Panda completed the 390m trial distance in a time of 22.09. Super Panda placed 1st in a field of 5 winning by 11.25L. Super Panda has been cleared to race at all tracks except Healsville.

Sudoku Buddah – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a change of kennels. Weighing 33.8kgs and beginning from box 8, Sudoku Buddah completed the 390m trial distance in a time of 22.92. Sudoku Buddah placed 3rd in a field of 5 beaten by 12L. Sudoku Buddah has been cleared to race.

Hayley's Style – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Sandown for failing to chase. Weighing 25.7kgs and beginning from box 1, Hayley's Style completed the 450m trial distance in a time of 25.57. Hayley's Style placed 1st in a field of 4 winning by 2L. Hayley's Style has been cleared to race at all tracks except Sandown.

Spring Bomber – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Ballarat for failing to chase. Weighing 33.4kgs and beginning from box 3, Spring Bomber completed the 450m trial distance in a time of 25.71. Spring Bomber placed 2nd in a field of 4 beaten by 2L.
