MEETING COMMENTS:

The following Greyhounds performed a Stewards Satisfactory Trial - The trail took place over 460mtrs with 2 required to trial. The winning time of trial was 25.70:

Sure To Excite finished 1st, Sir Jay Jay finished 3rd.

Sure To Excite – Was stood down from racing at Sandown for failing to chase. Weighing 34.7kgs and beginning from box 1 winning by 4 1/4 lengths. Sure To Excite has been cleared to race at all tracks.

Sir Jay Jay – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a dislocated front right toe. Weighing 36.6kgs and beginning from box 8 beaten by 6 lengths. Sir Jay Jay has been cleared to race at all tracks.
