Satisfactory Trials:

Zipping Stan – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Horsham for failing to chase. Weighing 31.9kgs and beginning from box 1, Zipping Stan completed the 390m trial distance in a time of 22.29. Zipping Stan placed 2nd in a field of 5 starters beaten by 0.5L. Zipping Stan has been cleared to race at all tracks except Horsham.

Titanium Springs – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Healesville for failing to chase. Weighing 27.9kgs and beginning from box 3, Titanium Springs completed the 390m trial distance in a time of 22.56. Titanium Springs placed 3rd in a field of 5 starters beaten by 4.25L. Titanium Springs has been cleared to race at all tracks except Healesville.

Broken Axle – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Ballarat for failing to chase. Weighing 32.1kgs and beginning from box 5, Broken Axle completed the 390m trial distance in a time of 22.26. Broken Axle placed 1st in a field of 5 of starters winning by 0.5L. Broken Axle has been cleared to race at all tracks.

Knockers Gold – Performed a Stewards Satisfactory trial as connections wish to remove blinkers from the greyhound. Weighing 30.8kgs and beginning from box 7, Knockers Gold completed the 390m trial distance in a time of 22.62. Knockers Gold placed 4th in a field of 5 of starters beaten by 5L. Knockers Gold has been cleared to race without blinkers.

Atomic Kitten – Performed a Stewards Satisfactory trial as connections wish to remove blinkers from the greyhound. Weighing 26.4kgs and beginning from box 8, Atomic Kitten completed the 390m trial distance in a time of 23.22. Atomic Kitten placed 5th in a field of 5 starters beaten by 13.5L. Atomic Kitten has been cleared to race without blinkers.

Base Camp – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Ballarat for failing to chase. Weighing 37.3kgs and beginning from box 1, Base Camp completed the 390m trial distance in a time of 22.28. Base Camp placed 1st in a field of 4 starters winning by a nose. Base Camp has been cleared to race at all tracks except Sandown & Horsham.

Sabotage – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a right front tendon injury. Weighing 35.0kgs and beginning from box 3, Sabotage completed the 390m trial distance in a time of 22.52. Sabotage placed 4th in a field of 4 starters beaten by 3.5L. Sabotage has been cleared to race.

Cabin Fever – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Sandown for marring. Weighing 35.0kgs and beginning from box 8, Cabin Fever completed the 390m trial distance in a time of 22.28. Cabin Fever placed 2nd in a field of 4 starters beaten by a nose. Cabin Fever has been cleared to race at all tracks except Sandown.
