Acting under the provisions of GAR 69(A)(1) Lloyd Bale was charged with failing to pursue the lure with due commitment. Mr Gibbons pleaded not guilty to the charge, Lloyd Bale was found guilty and suspended for 28 days at Geelong and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Weighing 27.0kgs and beginning from box 8, Zipping Keely completed the 400m trial distance in a time of 22.97. Zipping Keely placed 4th in a field of 5 starters beaten by 8L. Zipping Keely has been cleared to race at all tracks except The Meadows.</p>
