Acting under the provisions of GAR 69(A)(1) Crashing Lil was charged with failing to pursue the lure with due commitment. Mr Bosnich pleaded guilty to the charge, Crashing Lil was suspended for 28 days at Warragul and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A) (2)(a) before any future nomination will be accepted.

Satisfactory Trial Results:

The following Greyhounds performed a Stewards Satisfactory Trial – The trail took place over 400m with four greyhounds required to trial. The winning time of trial was 22.66;

Jaguar Jessie- Was stood down from racing at Sale for FTC (Injury.) Weighing 28.5kgs and beginning from box 8, winning by 5.75 lengths. Jaguar Jessie has been cleared to race all tracks except Sale.

Wash Out—Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to being on season. Weighing 28.5kgs and beginning from box 1, beaten by 8.5 lengths. Wash Out has been cleared to race.
