Meeting Comments:

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 300m with 4 greyhounds required to trial. The winning time of trial was 16.81.

North Wind finished 1st, Miss Ledekey finished 2nd.

North Wind – Was stood down from racing at Healesville for failing to chase the lure with due commitment. Weighing a new declared weight of 32.6kg, (last raced at 34.0kg), and beginning from box 1 winning by 1.75L. North Wind has been cleared to race at all tracks.

Miss Ledekey – Was stood down from racing at Healesville for failing to chase the lure with due commitment (by reason of injury). Weighing 25.0kg and beginning from box 8 beaten by 1.75L. Miss Ledekey has been cleared to race at all tracks.
