Meeting Comments:

Bastian Bale – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for Failing to Chase. Weighing 32.7kgs and beginning from box 3 Bastian Bale completed the 390m trial distance in a time of 23.17 Bastian Bale placed 2nd in a field of 4 of starters beaten by 0.75L. Bastian Bale has been cleared to race at all tracks.

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 450 with 4 greyhounds required to trial. The winning time of trial was 25.75.

Piper's Unicorn – Performed a Stewards Satisfactory Trial as connections wish to apply blinkers to the greyhound. Weighing 32.6kg and beginning from box 1. Piper's Unicorn placed 4th in a field of 4 of starters beaten by 15.75L. Piper's Unicorn has been not cleared to race in blinkers.

Lands End – Was stood down from racing at Sandown for Unsatisfactory Performance. Weighing 33.9kg and beginning from box 5 winning by 2.75L. Lands End placed 1st in a field of 4 starters winning by 2.75L. Lands End has been cleared to race at all tracks.
