Meeting Comments:

Stewards held an inquiry into the transportation used to convey Shining Opal to Bendigo today. Evidence was taken from Shining Opals' trainer Mr Brent Merton and Racing Steward Mr Ian Taylor. Mr Merton accepted that the transport used by him today failed to comply with the GRV Transportation of Greyhounds Policy. The compliance issue was that a single door was not securely fixed to the frame of the trailer. Stewards noted Mr Merton's forthright admissions and of importance, that the greyhound was not transported in the compartment (it was a 4 berth trailer) that was faulty. The Stewards of the Transportation of Greyhounds Policy, before using this vehicle again. Failing to correct the issue will result in more punitive

sanctions.
