No Recourse underwent a post-race veterinary examination and was found to have a left monkey muscle injury, a 10 day stand down period was imposed. Stewards spoke to Mr C. Russell, the handler of No Recourse regarding the greyhounds racing manners at the 100m mark. Acting under the provisions of GAR 69(B)(1) No Recourse was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Russell pleaded guilty to the charge. No Recourse must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

After reviewing the official race footage and acting on their own observations, Stewards were satisfied that as a consequence of the positioning of the lure, no greyhound had been substantially inconvenienced so as to affect the outcome of the event and the "All Clear" was given pursuant to GAR55(1). Stewards subsequently spoke to Lure Driver, Mr Lachlan Gough, regarding his drive for this event. Mr Gough advised that he may have been closer than the required distance on this occasion. Stewards will refer the matter to the appropriate Manager.

New England underwent a post-race veterinary examination and was found to have a left hind laceration and multiple sand toes. A 5 day stand down period was imposed. Stewards spoke to Trainer, Mr Peter Frost, regarding the greyhound's racing manners approaching the winning post. Taking into consideration the incident regarding the lure drive over the concluding stages for this event, Stewards took no action against New England.

A post-race blood sample was taken from All Bling - the winner of the event.

Meeting Comments:

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 300m with 4 greyhounds required to trial. The winning time of trial was 17.23:

Road To Nhill finished 2nd, Prima Mikado finished 1st, Rapid Rock finished 3rd.

Road To Nhill – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a right stopper injury. Weighing 33.8kg and beginning from box 1, beaten by 0.75L. Road To Nhill has been cleared to race at all tracks.

Prima Mikado – Was stood down from racing at Healesville for failing to pursue the lure with due commitment. Weighing 28.3kg and beginning from box 5, winning by 0.75L. Prima Mikado has been cleared to race at all tracks.

Rapid Rock – Was stood down from racing at Bendigo for marring. Weighing 27.2kg and beginning from box 8, beaten by 1.0L. Rapid Rock has been cleared to race at Healesville track only.
