Cavatate – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a right stopper injury. Weighing 33.9kgs and beginning from box 2, Cavatate completed the 390m trial distance in a time of 22.37 Cavatate placed 1st in a field of 7 starters winning by 2.75L. Cavatate has been cleared to race.

Scott Confusion – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of

six months due to being on season. Weighing 27.6kgs and beginning from box 5, Scott Confusion completed the 390m trial distance in a time of 23.18. Scott Confusion placed 5th in a field of insert number of 7 starters beaten by 11.75L. Scott Confusion has been cleared to race.

Cash No Bounce – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to unsatisfactory performance. Weighing 33.5kgs and beginning from box 8, Cash No Bounce completed the 390m trial distance in a time of 22.57. Cash No Bounce placed 2nd in a field of 7 starters beaten by 2.75L. Cash No Bounce has been cleared to race.

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 450m with 5 required to trial. The winning time of trial was 25.83:

Dyna Xervo finished 3rd, Bakali Louis finished 5th, All Dolled Up finished 1st.

Bakali Louis – Was stood down from racing at Geelong for Failing To Chase. Weighing 35.0kgs and beginning from box 2 beaten by 11.25L. Bakali Louis was not cleared to race, due to unsatisfactory performance.

Dyna Xervo – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a right toe injury. Weighing 31.0kgs and beginning from box 1, Dyna Xervo completed the 450m trial distance in a time of 25.94.
