Acting under the provisions of GAR 69(A)(1) Darnum Dynamite was charged with failing to pursue the lure with due commitment. Mr Handley pleaded guilty to the charge, Darnum Dynamite is suspended for 28 days at Healesville and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
