Satisfactory trials:

Dyna Penny – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to extended spell. Weighing 25.6kgs and beginning from box 1, Dyna Penny completed the 390m trial distance in a time of 22.72. Dyna Penny placed 3rd in a field of 5 starters beaten by 5.75L. Dyna Penny has been cleared to race.

Chile Allen – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a broken scapula. Weighing 29.9kgs and beginning from box 3, Chile Allen completed the 390m trial distance in a time of 22.33. Chile Allen placed 1st in a field of 5 starters winning by 1.25L. Chile Allen has been cleared to race.

Blue Sky Riot – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a right stopper bone injury. Weighing 29.1kgs and beginning from box 5, Blue Sky Riot completed the 390m trial distance in a time of 22.41. Blue Sky Riot placed 2nd in a field of 5 starters beaten by 1.25L. Blue Sky Riot has been cleared to race.
