Meeting Comments:-

Trial 1.

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 390mts with 4 required to trial. The winning time of trial was 22.36:

Chill Out Digby finished 2nd, Greysynd Spark finished 4th, Balance finished 1st, Chill Out Indy finished 3rd.

Chill Out Digby – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Sandown for marring. Weighing 30.0kg and beginning from box 1, Chill Out Digby completed the 390mt trial distance in a time of 22.58. Chill Out Digby placed 2nd in a field of 4 beaten by 3L. Chill Out Digby has been cleared to race at all tracks except Sandown.

Greysynd Spark – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Bendigo for marring. Weighing 23.8kg and beginning from box 3, Greysynd Spark completed the 390mt trial distance in a time of 22.92. Chill Out Digby placed 4th in a field of 4 beaten by 8L. Greysynd Spark has been cleared to race at all tracks except Bendigo.

Balance – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Bendigo for failing to chase. Weighing 33.3kg and beginning from box 6, Balance completed the 390mt trial distance in a time of 22.36. Balance placed 1st in a field of 4 winning by 3L. Balance has been cleared to race at all tracks except Bendigo.

Chill Out Indy – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Shepparton for failing to chase. Weighing 30.3kg and beginning from box 8, Chill Out Indy completed the 390mt trial distance in a time of 22.78. Chill Out Indy placed 3rd in a field of 4 beaten by 6L. Chill Out Indy has been cleared to race at all tracks except Meadows.

Trial 2.

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 390mts with 2 required to trial. The winning time of trial was 22.28:

Reckoning finished 1st, Rocketing Ruby finished 4th.

Reckoning – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to having injuries to stomach and back muscles. Weighing 32.9kg and beginning from box 1, Reckoning completed the 390mt trial distance in a time of 22.28. Reckoning placed 1st in a field of 4 winning by 8.25L. Reckoning has been cleared to race.

Rocketing Ruby – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to being seasonal. Weighing 28.6kg and beginning from box 8, Rocketing Ruby completed the 390mt trial distance in a time of 22.28. Rocketing Ruby placed 4th in a field of 4 beaten by 9.25L. Rocketing Ruby has been cleared to race.
