The following greyhounds Performed a Stewards Satisfactory Trial – The trial took place over 390m with 4 greyhounds required to trial. The winning time of trial was 23.14: Tycoran Gold finished 2nd, Cordillo finished 3rd, Fast Freddie finished 5th, Refueled finished 1st.

Tycoran Gold – Performed a Stewards Satisfactory Trial as connections wish to apply blinkers to the greyhound. Weighing 33.4kgs and beginning from box 1, Tycoran Gold completed the 390m trial distance in a time of 23.16. Tycoran Gold placed 2nd in a field of 6 starters beaten by neck Tycoran Gold has not cleared to race in blinkers as the greyhound failed to perform to satisfaction of the stewards.

Cordillo – Performed a Stewards Satisfactory Trial as the greyhound has not competed in an event for in excess of six months due to a right back muscle injury. Weighing 31.4kgs and beginning from box 3, Cordillo completed the 390m trial distance in a time of 23.27 Cordillo placed 3rd in a field of 6 of starters beaten by 1.75L. Cordillo has been cleared to race.

Fast Freddie – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for unsatisfactory performance. Weighing 31.6kgs and beginning from box 4, Fast Freddie completed the 390m trial distance in a time of 23.68. Fast Freddie placed 5th in a field of 6 starters beaten by 7.5L. Fast Freddie has been cleared to race at all tracks.

Refueled – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for unsatisfactory performance. Weighing 32.6kgs and beginning from box 8, Refueled completed the 390m trial distance in a time of 23.14. Refueled placed 1st in a field of 6 starters winning by neck. Refueled has been cleared to race at all tracks.

The following greyhounds performed a Stewards Satisfactory Trial – The trial took place over 450m with 3 greyhounds required to trial. The winning time of trial was 25.88: Maina Honey finished 3rd, Lana Bale finished 1st, Ophira Bale finished 2nd.

Maina Honey – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for fail to chase due to injury. Weighing 27.5kgs and beginning from box 1, Maina Honey completed the 450m trial distance in a time of 25.98. Maina Honey placed 3rd in a field of 4 starters beaten by 1.5L Maina Honey has been cleared to race at all tracks.

Lana Bale – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for marring. Weighing 31.4kgs and beginning from box 3, Lana Bale completed the 450m trial distance in a time of 25.88. Lana Bale placed 1st in a field of 4 starters winning by neck. Lana Bale has been cleared to race at all tracks.

Ophira Bale – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for marring Weighing 30.9kgs and beginning from box 7, Ophira Bale completed the 450m trial distance in a time of 25.90. Ophira Bale placed 2nd in a field of 4 starters beaten by neck. Ophira Bale has been not cleared to race after visably easing in the home straight.
