Geall, regarding the greyhounds racing manners approaching the home turn, on the home turn and in the home straight. Acting under the provisions of GAR 69(B)(1), Lands End was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Geall pleaded not guilty to the charge, Lands End was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
