Ms. Gill pleaded guilty to the charge, Paz is suspended for 28 days at The Meadows and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Weblec Fire underwent a post race veterinary examination and was found to have an injury to the left chest muscle and a spike wound to the right hock. A 5 day stand down period was imposed.

Stewards spoke to Mr Jeffrey Britton, the trainer of Weblec Fire regarding its performance in this event. Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Weblec Fire must

perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.
