Violation underwent a post race veterinary examination and was found to have a left back muscle injury and an abrasion to the right stopper. A 5 day stand down period was imposed.

Stewards spoke to Mr Steven Kyriacopoulos, the trainer of Violation regarding the greyhounds racing manners approaching the home turn. Acting under the provisions of GAR 69(1) Violation was charged with marring. Mr Kyriacopoulos pleaded not guilty to the charge, Violation was found guilty and suspended for 3 months at all tracks and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(b) before any future nomination will be accepted.

Galloping Eddie underwent a post-race veterinary examination at the request of the trainer and was found to have a left wrist injury and right triangle muscle injury. A 5 day stand down period was imposed.
