Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff &amp; Participants) attending today, undertook successful health screenings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <p align="center">-----</p> <p>Midnight Drifter, Pretty Fly and Insidious Rio were slow to begin.</p> <p>Midnight Drifter and Insidious Rio collided continuously from soon after the start to the 200m mark. Acting under the provisions of GAR 69(B)(1), Riccarton Rain was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Hellenen pleaded guilty to the charge, Riccarton Rain must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p>

Mr Bowman pleaded guilty to the charge, Willy Eve is suspended for 28 days at Healesville and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.</p> <p>Spanish Paso underwent a post-race veterinary examination and was found to have a right hindleg hip injury, a seven day stand down period was imposed. Stewards spoke to trainer, Mr A Rocke regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(B)(1), Spanish Paso was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Rocke pleaded guilty to the charge, Spanish Paso must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p> <p>A post-race sample was taken from American Missile - the winner of the event.</p>
