Stewards noted Ms Barber's explanation and after taking into consideration the injury sustained to the greyhound, took no action in the matter.

A 14 day stand down period was imposed.</p> <p>Stewards spoke to Mr Luckie Karabitsakos after he failed to present Rico's Amore for a post-race veterinary examination. Mr. Karabitsakos advised that he was unaware the greyhound was to be vetted and that the greyhound had left the course with a family member. Stewards directed that Mr Karabitsakos present Rico's Amore at Cranbourne on Wednesday, 4 September, 2019 for an examination by the on-course Veterinarian. Stewards also reminded Mr Karabitsakos that he must obtain a clearance by Stewards before allowing his greyhounds to leave the course.</p> <p>Campini - Performed an exhibition trial over 515m from box 1, weighing 31.4kg in a time of 29.44.A pre-race sample was taken from Campini.</p>
