Stewards spoke to trainer Mr Kevin Mugavin regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(B)(1), Cloona Reward was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Mugavin pleaded not guilty to the charge, Cloona Reward was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
