Galway Lights and Infinite Will collided on the first turn. All Inn June and Dicky's Girl collided on the first turn checking Dicky's Girl. Jodie's Boy, Infinite Will and Galway Lights collided approaching the home turn checking Galway Lights and Infinite Will. Thirty Red and Infinite Will collided on the home turn.

Dicky's Girl underwent a post-race veterinary examination and was re-examined following race 3. Dicky's Girl was found to have an injury to the left back muscle. A 10 day stand down period was imposed.

Jodie's Boy underwent a post-race veterinary examination and was found to have vomited. No stand down period was imposed.

Following the event Remember Jimmy displayed signs of Post Exercise Distress Syndrome (PEDS). As a result, the greyhound underwent a veterinary examination and was found to be displaying clinical signs of Ataxia/Hypermetria. A 10 day stand down penalty was imposed.

Stewards spoke to Mr G. Orr, the trainer of Remember Jimmy and advised him that the greyhound would be closely monitored in future events.

Acting under the provisions of GAR 69(B)(1), Dusty Victorem was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Gray pleaded guilty to the charge, Dusty Victorem must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
