Mr Eyles pleaded guilty to the charge, Kraken Rye must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

Zipping Brandy underwent a post-race veterinary examination - no stand down period was reported.

Stewards spoke to Mrs S. Northway, the trainer of Zipping Brandy regarding the greyhounds racing manners approaching the home turn and on the home turn. Acting under the provisions of GAR 69(A)(1) Zipping Brandy was charged with failing to pursue the lure with due commitment. Mrs Northway pleaded guilty to the charge, Zipping Brandy is suspended for 28 days at Cranbourne and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
