Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff, at all times.

Mr. Formosa pleaded guilty to the charge, Tommy's No Angel must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
