Acting under the provisions of GAR 69(A)(1) Spandau Ballet was charged with failing to pursue the lure with due commitment. Mr Willoughby pleaded guilty to the charge, Spandau Ballet is suspended for 3 months at all tracks and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(b) before any future nomination will be accepted. Van Wilson, which fell on the finish on lure, underwent a post-race veterinary examination and was found to have a right radius/ulna fracture. A 90 day stand down period was imposed.
