Stewards spoke to Trainer Mr. T. Sinnott, regarding the greyhounds racing manners in the home straight. Acting under the provisions of GAR 69(B) (1), Chill Out Pedro was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. T. Sinnott pleaded not guilty to the charge, Chill Out Pedro was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p> <p>Trainer Mr T. Sinnott was questioned regarding a wound to the left hind stifle. After taking evidence from Mr Sinnott regarding the injury and his treatment practices, and also giving consideration to recommendations from the On Track Veterinarian, Stewards ordered Mr Sinnott to produce a veterinary certificate to the satisfaction of Stewards pursuant to GAR 20(3)(v) prior to the greyhound being nominated.</p>
