Race 1

Stewards spoke to Ms P. Triaca, the Trainer of Legend Grace regarding its performance in this event. Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Legend Grace must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.

Acting under the provisions of GAR 69(1) Bernmar Junior was charged with marring. Mr Borradale pleaded not guilty to the charge, Bernmar Junior was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
