Acting under the provisions of GAR 69(B)(1), Humphrey Bear was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Hammerstein pleaded guilty to the charge, Humphrey Bear must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

Permit Granted underwent a post-race veterinary examination and was re-examined following race five, no apparent injury could be detected.

Stewards spoke to Mr Patrick Bull, the trainer of Permit Granted, regarding the greyhounds racing manners approaching the home turn. Acting under the provisions of GAR 69(A)(1) Permit Granted was charged with failing to pursue the lure with due commitment. Mr Bull pleaded guilty to the charge, Permit Granted is suspended for 28 days at Horsham and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Anyone Arby underwent a post-race veterinary examination and was found to have a left hindleg pencil/whip injury. A three day stand down period was imposed.
