	SUPPLEMENTARY REPORT:
	As directed by Stewards, Miss Ashley Terry reported that Van Nindi had been examined by Dr Des Fegan on Wednesday 21st November 2019 where it was noted that the greyhound had sustained a severe right shoulder sprain. Dr Fegan recommended that Van Nindi be rested for 10-14 days and then be re- examined.
