Tanami Express was found to have injuries to the right quadriceps, the right pencil muscle and the left monkey muscle. A 10 day stand down period was imposed. Stewards spoke to Mr B. Smith, the trainer of Tanami Express regarding the greyhounds racing manners at the 50m mark and again approaching the winning post. Acting under the provisions of GAR 69(B)(1), Tanami Express was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Smith pleaded guilty to the charge, Tanami Express must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
	Ovens Angler underwent a post-race veterinary examination and was found to have injuries to the right pencil muscle and the left hip. A 10 day stand down period was imposed. Stewards spoke to Mr G. Cinnamond, the handler of Ovens Angler regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(1) Ovens Angler was charged with marring. Mr Cinnamond pleaded not guilty to the charge, Ovens Angler is suspended for 28 days at Healesville and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
