Stewards spoke to trainer, Mr Adam Richardson, regarding the greyhounds racing manners in the home straight. Acting under the provisions of GAR 69(B) (1), Fireball Frank was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Richardson pleaded guilty to the charge, Fireball Frank must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

Stewards spoke to Mr Scott Melville, the trainer of Shima Deal regarding its performance in the event. Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Shima Deal must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.

A post-race sample was taken from Zambora Clown - the winner of the event.

Print The Cash underwent a post-race veterinary examination and was found to have injuries to the lumbosacral and abdominal muscle. A 10 day stand down period was imposed.

Stewards spoke to Ms Michelle Mallia, the trainer of Print The Cash and acting under GAR 75 (1) Stewards ordered Ms Mallia to report as soon as practicable anything that may have affected the running of Print The Cash in the event which was not noted by Stewards during or immediately after the event.
