Acting under the provisions of GAR 69(B)(1), Little Tubbsy was charged with failing to pursue the lure with due commitment (by reason of injury). Ms McRae pleaded guilty to the charge, Little Tubbsy must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
