Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.

All persons (both Staff & Participants) attending today, undertook successful health screenings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.

Stewards spoke to representative Mrs. J McMahon regarding the scratching of greyhounds Dr. Lynch and Dr. Collette and noted the explanation and advised that both greyhounds will require a veterinary certificate before further nominations in accordance with GAR 20(3)(v).
