Mr. Lieshout pleaded guilty to the charge, Jackson's River is suspended for 12 months at all tracks and must perform a satisfactory trial (all tracks) pursuant to GAR 69(A)(2)(c) before any future nomination will be accepted.

Airly Spence proved difficult to box and will be boxed first in future events in accordance with GAR 52.
