Handlers are required to exit the area after boxing and maintain their 1.5m distance from other handlers and staff at all times.</p> <p>All persons (both Staff &amp; Participants) attending today, undertook health screenings that in-turn, permitted entry to the venue for exclusive race-day functions and operations.</p> <hr/> <p>Weblec Pearl was slow to begin. Ragin' Outcast went up with the box lids and was slow to begin.</p> <p>Amelie Otis checked off BuyThe Dip soon after the start. Ragin' Outcast checked off Taiapa approaching the first turn. Ragin' Outcast and Weblec Pearl collided approaching the first turn, checking both greyhounds. Buy The Dip checked off Urana Rose on the first turn, severely checking Taiapa and Lainey Basil. Urana Rose veered out and marred the running of Glamorous Lass entering the home straight. Mr. G.Glass pleaded guilty to the charge, Urana Rose is suspended for 28 days at Ballarat and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.</p> <p>Ragin' Outcast underwent a post-race veterinary examination and was found to have a monkey muscle injury, right foreleg.
