Mr Mugavin pleaded guilty to the charge, Spring Classic must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

Aron Allen underwent a post-race veterinary examination and was found to have a right hindleg quadriceps injury. A 3 day stand down period was imposed.

Stewards conducted a check of all catcher's licences in accordance with LR 16.2 for the night, all were compliant.
