Egoline Zeb underwent a post race veterinary examination and no apparent injury was reported. Trainer Mr. A. Smit declined his option to have the greyhound re-vetted.

Stewards spoke to Mr. A. Smit the trainer of Egoline Zeb regarding the greyhound's racing manners approaching the home turn. Acting under the provisions of GAR 69(A)(1) Egoline Zeb was charged with failing to pursue the lure with due commitment. Mr. Smit pleaded guilty to the charge, Egoline Zeb is suspended for 28 days at Warragul and must perform a satisfactory trial (all tracks) pursuant to GAR 69(A) (2)(a) before any future nomination will be accepted.
