Ms Gill pleaded guilty to the charge, Paxton must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p> <p>High Garden underwent a post-race veterinary examination and was re-examined following race 8 - no apparent injury was reported.</p> <p>Stewards spoke to Ms L. Dalziel, the representative of High Garden regarding the greyhounds racing manners on the first turn. Acting under the provisions of GAR 69(A)(1) High Garden was charged with failing to pursue the lure with due commitment. Ms Dalziel pleaded guilty to the charge, High Garden is suspended for 28 days at Cranbourne and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.</p> <p>Kip Your Star underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Stewards spoke to Mr S. Kipirtidis, the trainer of Kip Your Star regarding the greyhounds racing manners approaching the winning post. Acting under the provisions of GAR 69(A)(1) Kip Your Star was charged with failing to pursue the lure with due commitment. Mr Kipirtidis pleaded guilty to the charge, Kip Your Star is suspended for 12 months at all tracks and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(c) before any future nomination will be accepted.</p>
