Acting under the provisions of GAR 69(1) Bandwagon was charged with marring. Mr Presutto pleaded guilty to the charge, Bandwagon is suspended for 28 days at Sandown and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
